Vacancy – Terms of reference

Job description

PURPOSE: The FuStDev position aims to drive the development and optimisation of web applications for LifeWatch ERIC, enhancing research capabilities in biodiversity and ecosystem analysis through innovative software solutions.

JOB TITLE: Full Stack Developer

LOCATION: ICT-Core premises in Seville, Spain

POSITION: Full-Time

Main responsibilities

- S/he will hold a position which requires multi-, inter- and trans-disciplinary ICT skills accrediting proven experience on different kind of networks with the need for supervision, modifications through programming and continuous monitoring;
- She/he will be instrumental in designing, developing, and deploying both front-end and back-end components of web applications, ensuring they meet the high standards of performance, quality, and responsiveness expected by LifeWatch ERIC. This role requires a collaborative approach to work closely with project managers, data scientists, and other stakeholders, effectively translating user requirements into robust software solutions. The developer will also be responsible for maintaining and

enhancing the scalability of existing applications, implementing security measures, and ensuring data protection;

- She/he will engage in troubleshooting, debugging, and upgrading software to keep applications running smoothly. Writing clean, maintainable code is a must, alongside participating in code reviews to ensure best practices. The role extends to providing technical support and creating comprehensive documentation for the developed applications. Staying updated with the latest industry trends in web development and programming languages, as well as contributing to the continuous improvement of the development process through CI/CD pipelines, are also key responsibilities.

The ideal candidate should meet the following requirements

- A bachelor's degree in Computer Science, Engineering, or relevant training in the field is preferred;
- Minimum 3-year experience in programming environments in companies and sufficiently relevant environments;
- Proven experience as a Full Stack Developer or similar role;
- Proficiency in front-end languages and frameworks (e.g., HTML, CSS, JavaScript, React, Angular, Vue);
- Strong knowledge of back-end languages (e.g., Python, Java, PHP) and JavaScript frameworks (e.g., Node.js, Express);
- Experience with database technology (e.g., MySQL, MongoDB, PostgreSQL);
- Familiarity with server, network, and hosting environments;
- Understanding of API design and development;
- Good knowledge of code versioning tools, such as Git;

- Experience with continuous integration and deployment (CI/CD) pipelines;
- Good communication skills and proficiency in English (Minimum B2 Level);
- Proven organisation and communicative skills, proactivity, capacity of working in teams and under tight deadlines, in international environments and in multi-language contexts;
- Be available to travel abroad occasionally according to the specific working needs of this position;
- High-standard work ethics.

The vacancy is subject to the following procedure

- A competitive gross salary, based on the qualifications and experience of the candidate, will be offered. Employment will be in Spain, follow Spanish employment law and subject to a 180-day trial (probation) period;
