## A. Job description

JOB TITLE: Distributed e-Infrastructure Control & Network Systems Manager

**PURPOSE:** The DeInfCNSM will assist in the coordination of the day-to-day ICT-Core network (HPCs, servers, VMs, etc.) components allocated either at Common or Distributed Facilities to guarantee the efficient engagement of the LifeWatch ERIC distributed e-Infrastructure of associated devices and software (e-Services, etc.)

LOCATION: LifeWatch ERIC ICT-Core premises in Andalusia (Spain)

**POSITION:** Full-time, 18-month period, renewable

**FUNDING RESOURCES:** LifeWatch ERIC ICT-Core in Spain - Andalusia ERDF Projects Framework 2014 - 2020 (POPE); EOSC Future and AgroServ projects

**COMPENSATION:** Competitive salary, commensurate to degrees and relevant experience

#### **B. Main responsibilities**

I. S/he will work under the supervision of, and always directly report to the Chief Technology Officer and Head of the ICT-Core;

II. S/he will hold a position which requires multi-, inter- and trans-disciplinary ICT skills accrediting proven research experience on different kind of networks with the need for





supervision, modifications through programming and continuous monitoring;

II. She/he will provide full support for the co-design, start-up, deployment, monitoring and performance assurance of LifeWatch ERIC network components.

# C. The ideal candidate should meet the following requirements:

- A Bachelor's degree in Informatics or Telecommunications Engineering;
- Minimum 10-years' experience in in management and monitoring of networks;
- International experience in a work/educational environment;
- Accredited professional experience on innovation projects related to communications and data processing;
- Excellent presentation and reporting skills, fluency in written and spoken English (LifeWatch ERIC's Official language) and Spanish (ICT-Core premises hosted by Spain);
- Knowledge of other European languages will be taken into consideration;
- Advanced knowledge of operating systems (Windows, Linux, Unix); programming languages (C++, Java, J2EE); databases (Oracle, SQL-Server) and Active Directory;
- Knowledge and experience in cybersecurity, industrial communication protocols and communications devices and tools;
- Proven organisation and communicative skills, proactivity, capacity of working in teams and under tight deadlines, in international environments and in multi-language contexts;
- Be available to travel abroad according to the specific working needs of this position;
- High-standard work ethic.

- Understanding of the structure, functioning and regulation of European Research Infrastructure Consortia (ERICs), in particular ICT, biodiversity and ecosystem areas.
