A. Job description

JOB TITLE: Integrated Water Resources Biodiversity Ecosystem Services ICT Project Manager -IWR_BES_ICTPM-

LOCATION: LifeWatch ERIC ICT-Core premises in Seville, Andalusia (Spain)

POSITION: Full-time

FUNDING RESOURCES: LifeWatch ERIC ICT-Core – Multi-regional Operational Programme for Spain ERDF (European Regional Development Fund) 2014–2020, for actions related to LifeWatch ERIC e-infrastructure located in the Autonomous Community of Andalusia; other modalities of ERDF (2021–2026), Next Generation, and Horizon Europe Funds

COMPENSATION: Competitive salary, commensurate to degrees and relevant experience

B. Main responsibilities

- I. S/he will work under the supervision of, and directly report to, the PI of LifeWatch ERIC for the ERDF Projects, the CTO/Head of ICT-Core and FEDERTECH Offices, and/or the person(s) he may delegate, to carry out of the following tasks, activities and deliverables:
 - (1) Integrated Water Resources Projects Information and Communication Technologies Project Management, including the technical direction addressed





to the co-design, co-deployment, co-maintenance, and coordination of the associated distributed e-Infrastructure elements (hardware, software and staff);

- (2) Support with the financial administration needed under the legal parameters of ICT-Core projects, in particular, EU Framework Programmes, INTERREG, ESIF (S4-ERDF), EU NDICI, and Next Generation grants, among others;
- (3) Support in the preparation of financial statements and reports, associated with ICT-Core projects;
- (4) S/he will assist the CTO/Head of ICT-Core, as well as other LifeWatch ERIC staff members in the development of procurement documents and calls for applications.

C. The ideal candidate should meet the following requirements

- University degree in Informatics and/or Telecommunication Engineering;
- Master's degree in Industrial Organisation, on Telecommunication Network Designrelated topics will be also taken into account;
- At least a 20-year period of professional experience as an engineer at both public and private sector levels, from which at least 10 years must be related to accredited activities in ICT engineering in the Integrated Water Resources Management field;
- Fluency in writing and editing, as well as spoken fluency in English (B2 level minimum);
- Fluency in writing and editing, as well as spoken fluency in Spanish (B2 level minimum);
- Ability to work under tight deadlines with changing priorities, availability to occasionally work beyond office hours and on weekends as required;





- Willingness to travel abroad according to the specific working needs of this position;
- High-standard work ethic.
